## Brief

National Fellowship is a Central Scheme to providing fellowship to Scheduled Tribe students for pursuing higher studies such as M. Phil and Ph.D., in all the Universities/Institutions recognized by the University Grant Commission (UGC). The total number of tresh fellowships each year is 750. The amount covers fellowships, contingency expenses, HRA on UGC pattern etc. and is being disbursed through DBT mode. The maximum duration for the scholarships course is (i) M. Phil-2 years, (ii) Ph. D exclusively-5 years and (iii) M. Phil + Ph. D-2 years (M. Phil) and 3 years (Ph. D). Funds released and beneficiaries are:

The scheme has been onboarded on DBT Mission's Bharat Portal. An amount of Rs. 100 cr. has been allocated for the year 2018-19 under the scheme.

Scholarship is also a Central Scheme for Scheduled Tribe students introduced with the objective of encouraging meritorious ST students for pursing studies at Degree and Post Graduate level in any of the Institutes identified by the Ministry of Tribal Affairs for the purpose. It supports meritorious ST students who gain admission in 159 identified quality educational institutions. The total no. of fresh scholarship every year is 1000. The amount covers tuition fees, boarding and lodging expenses, book grant and a greetime grant for purchase of a Computer along with its accessories. Full amount of tuition fee and other non-refundable dues in respect of Government/Government-funded institutions are paid.

In case of students studying in private sector institutions a ceiling of Rs. 2.00 lakh per annum per student will apply normally. Funds released and beneficiaries are:
